QUESTION 1

(Park Property)
SHALL THE FOLLOWING BE APPROVED?

Should the City of Kansas City remove from the park system approximately a thirty-six (36) acre tract in Hodge Park generally located in the northeast corner of the park off Northeast Shoal Creek Parkway and authorize the City to convey said property to a school district for use as a public school for such terms and consideration as the City may determine?

CITY OF KANSAS CITY, MISSOURI QUESTION 2

(Park Property)
SHALL THE FOLLOWING BE APPROVED?

Should the City of Kansas City remove from the park system property known as Belvidere Park containing approximately 15.46 acres generally located north of Independence Avenue between Tracy Avenue the Paseo Expressway which has been determined by the Board of Parks and Recreation Commissioners to be no longer necessary or appropriate for park, parkway, or boulevard use?
