**KCPS Redistricting  
Public Hearings to Begin  
This Week**

**KANSAS CITY, MO (October 14, 2021) – The first of three public hearings for the redistricting of the Kansas City Public School subdistricts will be taking place this Friday, October 15, 2021 at noon (12:00 PM) in the KC Public School office located at 2901 Troost Ave. KCMO 64109. **The purpose of this meeting will be to gather feedback on the current map with population changes and use that information to develop five (5) sample maps.**

**The next meeting, at which public input will be gathered about the five (5) sample maps, be held on Thursday, October 21, 2021 at 6:00 PM, also at 2901 Troost Ave. KCMO 64109. **The final public hearing will take place Tuesday, November 2, 2021 at 6:00 PM at 2901 Troost Ave. KCMO 64109. At this meeting the three final maps will be presented, including any community-submitted maps, for public consideration and input. **The Kansas City Board of Elections has been designated by statute to serve as the redistricting commission for the Kansas City Public Schools. The Board of Commissioners, sitting as the redistricting commission, is responsible to redistrict the Kansas City Public School subdistricts based on the results of the 2020 Census. The**

**purpose of these hearings is to gather input from the KCMO community in an effort to create subdistrict maps that best reflect the needs of the KCMO community.**
