## SPECIAL SCHOOL BOND ELECTION CONSOLIDATED SCHOOL DISTRICT NO. 4 OF JACKSON COUNTY, MISSOURI QUESTION

Shall the Board of Education of the Consolidated School District No. 4 of Jackson County, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of Seven Mission Dollars (\$7,000,000) for the purpose of completing renovation, remodeling and repair improvements to the existing facilities of the District including, without limitation, heating, ventilation and air conditioning improvements, roof repairs and replacement where necessary, parking lot improvements, window replacement; provide for the instructional need; and issue bonds, a portion of which may include Qualified Zone Academy Bonds in an amount not to exceed an allocation from the Missouri Department of Elementary and Secondary Education, for the payment thereof?
